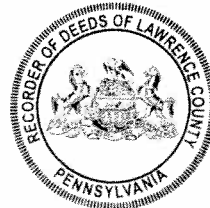

ORDINANCE OF WAYNE TOWNSHIP NO. 2 of 2009

An Ordinance of Wayne Township, Lawrence County, Pennsylvania, Ordaining a Section of Plum Way from Reserve Square Northerly a Distance of 660 Feet to its Intersection with Howard Street.

WHEREAS, Wayne Township has maintained Plum Way for a number of years and desires that said section of Plum Way be ordained as a public street.

NOW THEREFORE, it is enacted and ordained by the Supervisors of Wayne Township, Lawrence County, Pennsylvania, as follows:

Section 1.


That portion of Plum Way from Reserve Square Northerly a distance of 660 feet to its intersection with Howard Street is hereby ordained as a public street of the Township.

Section 2.

A copy of this Ordinance shall be filed in the Office of the Prothonotary and Clerk of Courts of Lawrence County, Pennsylvania, in accordance with the provisions of the Second Class Township Code.


