

WAYNE TOWNSHIP, LAWRENCE COUNTY, PENNSYLVANIA

ORDINANCE NO. 1 of 2016

AN ORDINANCE OF THE WAYNE TOWNSHIP, LAWRENCE COUNTY, PENNSYLVANIA, AUTHORIZING INTERGOVERNMENTAL COOPERATION WITH LAWRENCE COUNTY, THE BOROUGH OF ELLWOOD CITY, TOWNSHIP OF LITTLE BEAVER, BOROUGH OF ENON VALLEY, BOROUGH OF NEW BEAVER, BOROUGH OF WAMPUM, TOWNSHIP OF WAYNE, BOROUGH OF ELLPORT, TOWNSHIP OF SLIPPERY ROCK AND TOWNSHIP OF PERRY PROVIDING FOR CENTRAL BOOKING FOR ALL INDIVIDUALS CHARGED WITH A CRIME ARE PROCESSED IN A CENTAL LOCATION.

SECTION 1:

This Ordinance is made and adopted by Wayne Township, Lawrence County, Pennsylvania, pursuant to the provisions of the Intergovernmental Cooperation Law, 53 Pa. C.S.A. §2301 *et seq.*

SECTION 2:

Wayne Township, in order to protect the health, safety and welfare of its citizens hereby ordains and enacts the Intergovernmental Cooperation Ordinance authorizing the Township of Wayne to enter into an Intergovernmental Cooperation Agreement with Lawrence County, the Ellwood City Borough, Township of Little Beaver, Borough of Enon Valley, Borough of New Beaver, Borough of Wampum, Township of Wayne, Borough of Ellport, Township of Slippery Rock and Township of Perry.

"Central Booking Program Intergovernmental Agreement " (hereafter the "Agreement").

SECTION 3.

The terms and conditions of the Agreement are set forth therein and a copy of the Agreement is appended to this Ordinance and incorporated herein by reference as though fully set forth at length.

SECTION 4.

The term of the Agreement shall set forth the date on which it is executed pursuant to this Ordinance and shall be five years commencing on the date of execution of the Agreement.

SECTION 5.

The purpose of this Agreement is to establish, fund and maintain a joint centralized booking program by Lawrence County for the Participants.

SECTION 6.

The financial obligations under the Central Booking program shall be paid by a booking center fund fee as set forth in 42 Pa. C.S.A. §1725.25 and assessed detainees by the Court.

SECTION 7.

The Lawrence County Correctional Facility will provide program, space, staffing and administrative oversight of the program.

SECTION 8.


The Board of Supervisors of Wayne Township hereby authorizes the Chairmen of the Board of Supervisors to execute this Agreement.


