The Wayne Township Supervisors 1418 Wampum Road, Ellwood City, PA 16117 held a Special Reorganizational meeting, Thursday, January 11, 2018 at 7:00 p.m.

Meeting opened with the "**Pledge of Allegiance**" and a "**Moment of Silence**" lead by Bill Hepler. Officer in attendance was Supervisor Rick Weingartner; and Township Solicitor, Ryan Long. Absent: Supervisor Charles Hutchison.

**Motion to Reappoint** Shari D Baney as **Secretary/Treasurer** made by Hepler; 2<sup>nd</sup> by Weingartner. Long recommended secretary maintain the minutes of this evening's meeting, Long recommend Board's appointment be retroactive from January 2, 2018 and the Board ratify any & all action done on behalf of the township. Ratification would include Lawrence County vacation/holidays. Long suggested secretary draft Resolution #2 of 2018 pertaining to that recommendation. Motion by Hepler be 50-cent/hr increase; 2<sup>nd</sup> by Weingartner. All in favor.

**Motion for Road Foreman or Assistant Road Foreman.** No action. Motion by Hepler to table this action; 2<sup>nd</sup> by Weingartner. Motion to hire one temporary Road Driver, PT @ \$15.00/hr. Recommended driver will be Ed Pogozelec, motion by Hepler; 2<sup>nd</sup> by Weingartner @ \$15.00. All in favor. Jackie Biega asked if the recommended driver had a license. Hepler said he did; just not a CDL; which is not required to drive in the township trucks.

**PSATS Convention attendees** – Motion by Hepler to permit Supervisors, Secretary, Asst Secretary, Attorney, Auditors to attend the Hershey Convention; 2<sup>nd</sup> by Weingartner. All in favor.

**Voting Delegate** at PSATS Convention – Hepler motioned for Shari Baney be the 2018 voting delegate, as done in the past; Weingartner 2<sup>nd</sup>. All in favor.

**COG Membership** – Hepler made a motion to continue membership for 2018; 2<sup>nd</sup> by Weingartner. All in favor.

**Right-To-Know Officer** – Hepler was the temporary RTK Officer. Hepler asked if anyone in the township could fill that position; Long said Shari Baney has attended seminars and knows what she is doing. Secretary declined role. Hepler recommended Roger Baney be appointed as RTK Officer; Weingartner 2<sup>nd</sup> motion. All in favor. There was a question as to when: date & time a person could come in and request a RTK. There is a time allowed to respond and an extension, if need be, for that RTK. Long wanted to know if fees and wages will be set. Hepler said they will address that at the February meeting.

**Motion to rescind the motion to add Bruce Badger to the Agriculture Committee.** Badger, as an Auditor, cannot by law hold any other office, Motion by Hepler; 2<sup>nd</sup> by Weingartner. All in favor. Hepler motioned to appoint Eric Gardner to serve in the Agriculture Committee, 2<sup>nd</sup> by Weingartner. All in favor.

**Peddler/Solicitation fee** – Hepler recommended the Peddler fee be set at \$10.00; 2<sup>nd</sup> by Weingartner. All in favor.

**Alleyway Closing Fee** – Continue at \$200.00 Alleyway Closing Fee recommend by Hepler; 2<sup>nd</sup> by Weingartner. All in favor.

**Zoning Appeal Solicitor** - Robert DiBuono was appointed the 2018 Solicitor for Wayne Township Zoning Appeals Board. Motion by Hepler; 2<sup>nd</sup>. by Weingartner. All in favor.

**Emergency Management Coordinator** —Hepler appointed Jackie Biega as EMC for 2018; 2<sup>nd</sup> by Weingartner. All in favor.

**Sewer Authority Board** – Motion to reappoint Seth Michaels to the Sewer Authority Board made by Hepler; 2<sup>nd</sup>.by Weingartner. All in favor.

**Zoning Appeal Board Member** – Motion by Hepler to reappoint Charles Rupani to the Zoning Appeal Board; 2<sup>nd</sup> by Weingartner. All in favor.

Township is not going to address **Item #3** for the **Tax Collector** position and/or resignation until the February meeting.

**Public Input –**

**Ed Kirchel** said the township cashed his check for the Junkyard Permit. He was asking for his permit. Hepler said the permit was signed; he would get it for him.
