RESOLUTION NO. 3 of 2022

A RESOLUTION OF WAYNE TOWNSHIP, LAWRENCE COUNTY, COMMONWEALTH OF PENNSYLVANIA, APPROVING AND AUTHORIZING THE UTILIZATION OF AMERICAN RESCUE PLAN FUNDS FOR THE PURPOSE OF PAYING THE ASSISTANT SECRETARY-TREASURER WAGES FOR TIME OFF WORK DUE TO COVID-19.

WHEREAS, Wayne Township received certain American Rescue Plan funds during the calendar year 2021 as the result of the COVID-19 pandemic;

WHEREAS, Wayne Township's Assistant Secretary-Treasurer missed ten (10) collective days of work as a consequence of COVID-19;

WHEREAS, the Board of Supervisors of Wayne Township believes that it is in the best interest of the Township to utilize certain American Rescue Plan funds for the purpose of paying the Assistant Secretary-Treasurer for work missed as a result of COVID-19; and,

NOW THEREFORE, be it resolved that:

1. Samantha Laszlo, Wayne Township's Assistant Secretary-Treasurer during calendar year 2021 missed ten (10) days of work as a result of COVID-19, which days were December 20 through December 24 and December 27 through December 31, 2021.

2. Samantha Laszlo shall be paid by the Township for the ten (10) days missed from work because of COVID-19 from the American Rescue Plan funds received by Wayne Township during calendar year 2021.

3. All resolutions or parts of resolutions inconsistent with this resolution are hereby superseded.


